



Morinville Photo Hunt Official Rules

How to enter the “Morinville Photo Hunt” contest:

1. These official rules (“Contest Rules”) apply to the “Morinville Photo Hunt” contest (referred to herein as the “Contest”). Acceptance of the Contest Rules is a prerequisite for entry into the Contest and entrants must always observe them.
2. The Contest begins May 4, 2020 at 12:01 a.m. MST and ends on May 10, 2020 at 4:00 p.m.
3. To enter the Contest, participants’ must go out into our community (while remaining at an appropriate physical distance) to take photos of each letter of “Morinville Growing Together” and send the completed photo to community@morinville.ca by 4 p.m. on May 10, 2020 to be entered in the prize draw
4. No purchase necessary to enter the Contest.
5. The Town of Morinville and Boston Pizza Morinville are the sponsors of the Contest.
6. To enter and to be eligible to win the Contest, entrants must be a resident of Morinville, Alberta (“Eligible Entrants”).
7. Photos must be taken in Morinville, Alberta
8. Copyrights to the photos taken of The Morinville Photo Hunt will remain with the Town of Morinville. By entering the Contest entrants grant the Town of Morinville a worldwide, irrevocable and perpetual license to feature images in any of its publications in any form and using any technology whether presently known of which may exist in the future including websites and promotional materials related to the Contest.
9. Prizes/Approximate Retail Values (“ARV”): Four (4) Prizes: A Pizza Party prize package will consist of 2-medium pizzas of their choice, 4-chocolate brownies and a six-pack of non-alcohol beverages (pop, ice tea, lemonade). Valued at approximately \$62.00
10. Prizes are not transferable, except at the Town of Morinville’s sole discretion. The prize is not transferable or substitutable by any winner. However, a Prize, or any portion thereof, may be substituted by The Town of Morinville for a prize of equal or greater value, at the Town of Morinville’s sole discretion for any or no reason. Prizes consist of only those items specifically listed as part of the prize.
11. On or about May 14, 2020 all entries will be added to a random draw. 4 prize winners will be randomly chosen.
 - a) The competition is open to any resident in Morinville.
 - b) No letters from license plates
 - c) Only one letter allowed from any given piece of text (for example a sign)
 - d) No natural objects in the shape of a letter. For example, a stick does not count as an “i”

Release and Indemnity

12. Before being awarded a Prize each potential winner will be required to execute and return, within the time stipulation the Town of Morinville, a release, indemnity and consent form stating that the potential winner has read and understood these Contest Rules, is eligible to receive the Prize under these Contest Rules, accepts the Prize as offered, consents to the public disclosure of the name and municipality of residence in conjunction with the identification of Contest Prize winners, and releases and indemnifies the Town of Morinville from any and all liability arising out of the potential winner's participation in the Contest and receipt and use of the Prize.

Compliance with Contest Rules

13. In the event that a winner does not comply with all the provisions as contemplated in these Contest Rules, the Town of Morinville may disqualify the potential winner and will contact the entrant with next highest scored garden, and the Town of Morinville shall be fully and completely released and discharged from any liability or responsibility in this regard. The provisions and procedures referred to above relating to the selection and notification of a potential winner, if applicable, shall be applied, with all necessary amendments, until a qualified winner has been duly selected, but in any event, no later than June 1, 2020.
14. By entering the Contest, all entrants and participants agree to accept and abide by these Contest Rules. All decisions of the Town of Morinville with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to the Contest.
15. All nomination forms become property of the Town of Morinville, which assumes no responsibility for garbled, lost, late, delayed, destroyed, or any computer errors or malfunctions. The Town of Morinville will not communicate with entrants or potential entrants, except to schedule judging, contact winners and provide Contest Rules if awarding prizes by email.
16. The Town of Morinville does not assume any responsibility for incorrect inaccurate capture of entry information, technical malfunctions, human or technical error, lost, delayed or garbled data or transmissions, omission, interruption, deletion, defect or failures of any telephone or computer line or network, computer equipment, software or any combination thereof. Entry materials-data that have been tampered with or altered are void. If, for any reason, in the opinion of the Town of Morinville in its sole discretion, this Contest is not capable of running as originally planned, or if the administration, security, fairness, integrity or the proper conduct of this Contest is corrupted or adversely affected including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures or any other causes beyond its control, the Town of Morinville reserves the right to cancel, terminate, modify, amend, extend or suspend this Contest including canceling any method of entry, and select a winner from previously received Eligible Entries.



Right to Modify or Cancel Contest

17. The Town of Morinville reserves the right to modify these Contest Rules without materially affecting the terms and conditions hereof, The Town of Morinville reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of this Contest or to be acting in violation of these Contest Rules or otherwise in a disruptive manner. The Town of Morinville reserves the right in its sole discretion to terminate the on-line portion, as applicable, of this Contest and conduct the Drawing from all on-line entries and all other entries (as applicable) previously received during the Contest Period. Any attempts to deliberately damage the Contest web site or to undermine the legitimate operation of the Contest may be a violation of criminal and civil laws, and should such an attempt be made, the Town of Morinville reserves the right to in its sole discretion to seek remedies and damages to the fullest extent of the law. The Town of Morinville shall not be held responsible for any errors of negligence that may arise or occur in connection with the Contest including any damage to an entrant's computer equipment, system or any combination thereof, as a result of their participation in this Contest or from downloading any material from the Contest web site, where applicable.

Applicable Law and Protection of Privacy

18. This Contest is subject to all applicable federal, provincial and municipal laws and regulations. The Contest is void where prohibited by law. By entering this Contest, each entrant consents to the collection, use and distribution of his or her personal information (information that identifies an entrant as an individual, such as home telephone number, Age and home address) by The Town of Morinville for the purposes of implementing, administering and fulfilling this Contest. The Town of Morinville will not sell or transmit this information to third parties except for the purposes of administering this Contest. Any personal information collected by the Town of Morinville during this Contest will be destroyed after the conclusion of the Contest and the awarding of the Prizes.

Effect of Inconsistency

In the event of any discrepancy or inconsistency between the terms and condition of these Contest Rules, statements by employees or agents of the Town of Morinville, and disclosures or other statements contained in any Contest related materials, including but not limited to the Contest entry form, or print or online advertising, the terms and conditions of these Contest Rules shall prevail, govern and control.

All intellectual property, including but not limited to trademarks, trade-names, logos, designs, promotional materials, web pages, source codes, drawings, illustrations, slogans and representations are owned by the Town of Morinville. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.
21. This Contest shall be governed by the laws in force in the Province of Alberta. By entering this Contest, all entrants attorn to the exclusive jurisdiction of the Courts of the Province of Alberta.
22. The headers provided in the Contest Rules do not form part of the Contest Rules and are only for the purpose of convenience.
